**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 17 AUGUST 2018**

The board of directors of the Company (the “**Board**”) is pleased to announce that all the proposed resolutions set out in the notice of the AGM were duly passed by the shareholders of the Company by way of poll at the AGM held on 17 August 2018.

Reference is made to the circular of Kenford Group Holdings Limited (the “**Company**”) dated 6 July 2018 (the “**Circular**”) and the notice of the annual general meeting (the “**AGM**”) dated 6 July 2018. Terms used in this announcement shall have the same meaning as those defined in the Circular unless the context requires otherwise.

At the AGM held on 17 August 2018, a poll was demanded by the chairman of the AGM for voting on all the proposed resolutions as set out in the notice of the AGM dated 6 July 2018.

As at the date of the AGM, the total number of issued shares of the Company was 445,646,000 shares, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM. There were no shares of the Company entitling the holder to attend and vote only against the resolutions or abstain from voting at the AGM and there was no restriction on any shareholders to cast votes on any of the resolutions at the AGM. The total number of shares held by the shareholders of the Company or their proxy(ies) who have attended the AGM and are entitled to vote is 261,996,500 shares, representing approximately 58.8% of the total number of issued shares of the Company as at the date of this announcement.

The Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited was appointed as the scrutineer for the purpose of vote-taking at the AGM. Set out below are the poll results in respect of the resolutions put to the vote at the AGM:
